

COURSE ORGANIZATION

Duration of this program is two years spread over six semesters. Each year is divided into 3 semesters of 4 months' duration. All the semesters except the last begin with a **contact session extending for 2-3 weeks**. Classes during the contact sessions are conducted from 08:30 am to 5:00 pm, Monday through Saturday. In the sixth semester, there is no contact session and the time is used for finalization of Dissertation or Original article.

ADMISSION CRITERIA

The applicants will be selected on the basis of details provided in the application form, admission test and interview.

ELIGIBILITY

- Medical and Dental Graduates with at least two years experience after graduation.
- Those who have already completed their DCPS-HCSM in past.

Preference will be given to those who have:

- Experience of working in a managerial position.
- Post-graduate qualification in related field such as DCPS-HCSM.
